**DECLARATION ON ARTICLE 6 PARAGRAPH (2) SUBPARAGRAPH C,
ARTICLE 9 PARAGRAPH (1) SUBPARAGRAPH A, ARTICLE 9
PARAGRAPH (2) AND RESERVATION ON ARTICLE 20
PARAGRAPH (2) OF THE PROTOCOL AGAINST THE
SMUGGLING OF MIGRANTS BY LAND, SEA AND AIR,
SUPPLEMENTING THE UNITED NATIONS CONVENTION
AGAINSTS TRANSNATIONAL ORGANIZED CRIME**

Declaration:

The Government of the Republic of Indonesia declares that the provisions of Article 6 paragraph (2) subparagraph c, Article 9 paragraph (1) subparagraph a, and Article 9 paragraph (2) of the Protocol will have to be implemented in strict compliance with the principles of the sovereignty and territorial integrity of a state.

Reservation:

The Government of the Republic of Indonesia, does not consider itself bound by the provision of Article 20 paragraph (2) and takes the position that dispute relating to the interpretation and application on the Protocol which have not been settled through the channel provided for in paragraph (1) of the said Article, may be referred to the International Court of Justice only with the consent of all the Parties to the dispute.

Pernyataan:

Pemerintah Republik Indonesia menyatakan bahwa ketentuan Pasal 6 ayat (2) huruf c, Pasal 9 ayat (1) huruf a, dan Pasal 9 ayat (2) Protokol akan dilaksanakan dengan memenuhi prinsip-prinsip kedaulatan dan keutuhan wilayah suatu negara.

Pensyarat:

Pemerintah Republik Indonesia menyatakan tidak terikat pada Pasal 20 ayat (2) dan berpendirian bahwa apabila terjadi perselisihan akibat perbedaan penafsiran dan penerapan isi Protokol, yang tidak terselesaikan melalui jalur sebagaimana dimaksud pada ayat (1) Pasal tersebut, dapat menunjuk Mahkamah Internasional dengan kesepakatan Para Pihak yang bersengketa.
