

ELUCIDATION OF  
REGULATION OF THE REGENCY OF BANYUWANGI NUMBER 11 OF 2014  
ON  
PUBLIC ORDER AND TRANQUILITY  
OF SOCIETY IN REGENCY OF BANYUWANGI

I. GENERAL

That one of the obligatory functions which is the authority of the Regional Government is the implementation of public order and tranquility of society as referred to in provisions of Article 14 section (1) points c of Law Number 32 of 2004 on Regional Government as amended twice, last by Law Number 12 of 2008.

The arrangement of public order and tranquility of society aims to ensure the creation of conducive conditions in Regency of Banyuwangi, because with a conducive situation it is expected that all activities that occur in Regency of Banyuwangi can be well controlled.

With the establishment of this Regional Regulation is expected to be guidance for government of Regency of Banyuwangi in order to maintain and control public order and tranquility of society, in order to realize the community life of Regency of Banyuwangi safely, orderly and comfortable.
