THE REGENT OF BANYUWANGI,

Considering : that in order to promote and develop activities business at the Regional Public Drinking Water Company in the Regency of Banyuwangi, as well as to improve fulfillment services the need for drinking water for people in the Regency of Banyuwangi, it is necessary to stipulate a Regional Regulation on Amendments to Regional Regulation Number 6 of 2014 on Regional Capital Investment to Third Parties.

To Issue : REGIONAL REGULATION ON THE AMENDMENT TO
REGIONAL REGULATION NUMBER 6 OF 2014 ON
INVESTMENT OF REGIONAL CAPITAL TO THIRD PARTIES.

Article I

Several provisions in the Regulation of the Regency of Banyuwangi Number 6 of 2014 on Regional Capital Investment to Third Parties (Gazette of the Banyuwangi of 2014 Number 10) is amended as follows:

1. The provisions of Article 3 the writing of numbers is changed to letters and added 1 (one) letter, namely letter m so that Article 3 reads as follows:

Article 3

- a. PT. Bank Pembangunan Daerah Jawa Timur Tbk;
- b. PT. Bank Perkreditan Rakyat Jawa Timur;
- c. PT. Merdeka Copper Gold Tbk;
- d. PT. Pelayaran Banyuwangi Sejati;
- e. Rice Milling Business Entities;
- f. Farmers Group;
- g. Cooperative;
- h. Small and Medium Enterprises;
- i. Small and Medium Industry;
- j. Street vendors;
- k. Freshwater Cultivator and Fishermen Group;
- l. Breeder Group;
- m. Public Drinking Water Company of the Regency of Banyuwangi.

2. The provisions of Article 4 the writing of numbers is changed into letters and added 1 (one) letter, namely letter e, so that Article 4 reads as follows:

Article 4

Permanent investment is given to:

- a. PT. Bank Pembangunan Daerah Jawa Timur Tbk. in the amount of Rp 67,509,029,250.00 (sixty-seven billion five hundred nine million twenty-nine thousand two hundred and fifty rupiah);
- b. PT. Bank Perkreditan Rakyat Jawa Timur, in the amount of Rp 8,000,900,000.00 (eight billion and nine hundred thousand rupiah);
- c. PT. Merdeka Copper Gold Tbk, in the amount of Rp 22,900,000,000.00 (twenty-two billion and nine hundred million rupiah);
- d. PT. Pelayaran Banyuwangi Sejati, in the amount of Rp 288,000,000.00 (two hundred and eighty eight million rupiah);
- e. Public Drinking Water Company of the Regency of Banyuwangi until 2021 in the amount of Rp 200,000,000,000.00 (two hundred billion rupiah)

the details are as follows:

1. Rp 33,886,953,887.04 (Thirty Three Billion Eight Hundred Eighty Six Million Nine Hundred Fifty Three Thousand Eight Hundred Eighty Five Seven Rupiah and Four Cents) in 1988 until 2015;
2. Rp 48,244,357,690.00 (Forty-Eight Billion Two Hundred Forty-Four Million Three Hundred Fifty Seven Thousand Six Hundred Nine Tens of Rupiah) in 2017;
3. Rp. 6,032,000,000.00 (Six Billion Thirty Two Million Rupiah) in 2018;
4. Rp 19,702,000,000.00 (Nineteen Billion Seven Hundred and Two Million Rupiah) plan for 2019;

5. Rp 59,395,207,333.96 (Fifty-Nine Billion Thirty Hundred Ninety Five Million Two Hundred Seven Thousand Three Hundred Thirty Three Rupiah, Ninety Six Cents) plan for 2020;
6. Rp 32,739,481,089.00 (Thirty-Two Billion Seven Hundred Thirty-Nine Million Four Hundred Eight Fifty One Thousand Eighty Nine Rupiah)

Article II

This regional regulation comes into force on the date of its promulgation.

In order that every person may know hereof, it is ordered to promulgate this regional regulation by its placement in the Regency Gazette of Banyuwangi.

I. GENERAL

Public Drinking Water Company of the Regency of Banyuwangi is a Regionally Owned Enterprise whose capital is wholly owned by the Government of the Regency Banyuwangi and is not divided into shares. As a Regionally Owned Enterprise, Public Water Company of the Regency of Banyuwangi was founded with the aim to provide benefits for economic development in the regency of Banyuwangi in general, and carry out in general benefits in the needs of drinking water for the people of Banyuwangi in the Regency Banyuwangi.

Given the importance of the existence of the Public Drinking Water Company of the Regency of Banyuwangi for the development of economy in the Regency of Banyuwangi and fulfillment of drinking water needs for the people of the Regency Banyuwangi, The Government of the Regency of Banyuwangi feels need to increase the capital investment to the Public Drinking Water Company, to support the development of business activities of Public Drinking Water Company of the Regency of Banyuwangi and increasing services to meet the needs of drinking water for people in the Regency of Banyuwangi.
