THE HEAD OF THE AGENCY FOR FOSTERING PANCASILA IDEOLOGY OF
THE REPUBLIC OF INDONESIA,

- Considering :
- a. that Pancasila as the basis, ideology and philosophy of the state is the source of all sources of state laws that is internalized and institutionalized in policies and legislation;
 - b. that based on the consideration as referred to in point a, it is necessary to issue a Regulation of Agency for Fostering Pancasila Ideology on Indicators of the Values of Pancasila;

- Observing:
1. Law Number 12 of 2011 on Legislation Making (State Gazette of the Republic of Indonesia Number 82 of 2011, Supplement to the State Gazette of the Republic of Indonesia Number 5234) as amended several times, last by Law Number 13 of 2022 on the Second Amendment to Law Number 12 of 2011 on Legislation Making (State Gazette of the Republic of Indonesia of 2022 Number 143, Supplement to the State Gazette of the Republic of Indonesia Number 6801);
 2. Presidential Regulation Number 7 of 2018 on Agency for Fostering Pancasila Ideology (State Gazette of the Republic of Indonesia of 2018 Number 17);

3. Regulation of the Agency for Fostering Pancasila Ideology Number 5 of 2021 on Organization and Work Procedures of the Agency for Fostering Pancasila Ideology (State Bulletin of the Republic of Indonesia of 2021 Number 938);

HAS DECIDED:

To issue: REGULATION OF THE AGENCY FOR FOSTERING PANCASILA IDEOLOGY ON INDICATORS OF THE VALUES OF PANCASILA.

Article 1

In this Agency Regulation Indicators of the Values of Pancasila means the embodiment of values and the actualization of values contained in Pancasila as the source of all sources of state laws.

Article 2

- (1) Indicators of the Values of Pancasila are used as guidelines in the establishment of policies and legislation making by state institutions, ministries/institutions, local governments, and village governments.
- (2) The establishment of policies and legislation making as referred to in section (1) include monitoring and reviewing of policies and legislation.

Article 3

The legislation making as referred to in Article 2 is aligned with the Indicators of the Values of Pancasila by the Agency for Fostering Pancasila Ideology.

Article 4

Indicators of the Values of Pancasila are listed in the Annex as an integral part of this Agency Regulation.

Article 5

This Agency Regulation comes into force on the date of its promulgation.

In order that every person may know hereof, it is ordered to promulgate this Agency Regulation by its placement in the State Bulletin of the Republic of Indonesia.

1. INDICATORS OF THE VALUES OF PANCASILA

Pancasila is the source of all sources of state laws that is placed as a meta-juridical basis for the birth of legal norms in policies and legislation. Indicators of the Values of Pancasila for policies and legislation are described in each of the principle as a unit that is interrelated and mutually supportive and cannot be separated from one another.

NO.	PRINCIPLE	DESCRIPTION
I.	FIRST	<p>BELIEF IN THE ONE AND ONLY GOD</p> <p>Policies and legislation established and made to provide protection and respect for everyone to believe and have piety in the Almighty God in accordance with their respective religions and beliefs in a civilized manner.</p> <p>Indicators:</p> <ol style="list-style-type: none"> 1. Policies and legislation guarantee that the nation of Indonesia is a nation that recognizes the existence of the Almighty God. 2. Policies and legislation guarantee that every citizen can practice the teachings of their religions and beliefs. 3. Policies and legislation guarantee freedom and respect for all followers of religions and beliefs to worship and carry out the obligations of their religions and beliefs. 4. Policies and legislation guarantee that everyone in carrying out the orders of their religions and beliefs in harmony with the life of society, nation, and state. 5. Policies and legislation guarantee respect for everyone to embrace their religions and beliefs.
II.	SECOND	<p>JUST AND CIVILIZED HUMANITY</p> <p>Policies and legislation established to provide recognition of equality, equal rights and equal obligations among human beings.</p> <p>Indicators:</p> <ol style="list-style-type: none"> 1. Policies and legislation guarantee the independence, sovereignty, unity and integrity of the nation as well as equality of relations among nations in the world. 2. Policies and legislation guarantee relations among nations by prioritizing national interests. 3. Policies and legislation uphold universal human rights while still considering national wisdom and maintaining equal, just and civilized relations among nations. 4. Policies and legislation reflect the recognition and equality of human beings in accordance with their dignity as creatures of the Almighty God. 5. Policies and legislation function to develop an attitude of mutual respect and respect for differences in ethnicity, religion, belief, race, and among groups.

III.	THIRD	<p>THE UNITY OF INDONESIA</p> <p>The policies and legislation established and made can foster the senses in every individual to belong to and love the Homeland as well as the willingness to protect the whole Indonesian nation and the land that has been struggled for.</p> <p>Indicators:</p> <ol style="list-style-type: none"> 1. Policies and legislation guarantee national unity, territorial unity and integrity of the Unitary State of the Republic of Indonesia, and develop culture. 2. Policies and legislation strengthen the national spirit that protects the whole Indonesian nation and the land that has been struggled for in the framework of the Unitary State of the Republic of Indonesia. 3. Policies and legislation guarantee that every citizen prioritizes the interests of the nation and state over personal or group interests. 4. Policies and legislation function to develop in every citizen a love for the homeland and a willingness to sacrifice for the interests of the nation and state. 5. Policies and legislation can foster a spirit of <i>gotong royong</i> (mutual cooperation), a sense of pride for the nation and for the homeland of Indonesia.
IV.	FOURTH	<p>DEMOCRATIC LIFE LED BY WISDOM OF THOUGHTS IN DELIBERATIONS AMONGST REPRESENTATIVES OF THE PEOPLE</p> <p>Policies and legislation formed to encourage and give respect to the aspirations and interests of the people in politics and continue to improve the system and democratic practice.</p> <p>Indicators:</p> <ol style="list-style-type: none"> 1. Policies and legislation always take into account to the fact that the State of Indonesia is not a state established for one group but for all people having Indonesia as their homeland based on the administration of the state amongst representatives of the people. 2. Policies and legislation take into account to wisdom in wisdom of thoughts in deliberations amongst representatives of the people based on the values of divinity, humanity, unity and social justice for all Indonesian people. 3. Policies and legislation guarantee democracy based on deliberations capable of realizing social welfare. 4. Policies and legislation guarantee that every citizen respects and upholds every decision made based on deliberation/consensus and implements the decision in good faith and a sense of responsibility. 5. Policies and legislation guarantee the implementation of a civilized and just political democracy.
V.	FIFTH	<p>SOCIAL JUSTICE FOR ALL THE PEOPLE OF INDONESIA</p> <p>The policies and legislation established and made can encourage the development of joint businesses in a spirit of mutual cooperation.</p> <p>Indicators:</p> <ol style="list-style-type: none"> 1. Policies and legislation function to realize justice and prosperity for all the people of Indonesia both physically and spiritually. 2. Policies and legislation guarantee protection for everyone to appreciate the creative process, works and initiatives in a

		<p>responsible manner for the realization of people's welfare.</p> <ol style="list-style-type: none">3. Policies and legislation guarantee the right of every citizen to obtain education, health service, employment, and business opportunities, as well as decent living.4. Policies and legislation established and made to foster economic self-sufficiency in society and just people's welfare.5. Policies and legislation guarantee economic activities that are just, sustainable, competitive, environmentally sound, and maintain a balance of growth and unity of national economy.
