

REGULATION OF THE NATIONAL CYBER AND CRYPTO AGENCY
NUMBER 1 OF 2018
ON
LOGO AND FLAG OF NATIONAL CYBER AND CRYPTO AGENCY

BY THE BLESSINGS OF ALMIGHTY GOD

HEAD OF THE NATIONAL CYBER AND CRYPTO AGENCY,

- Considering :
- a. that a logo symbolizes the identity and motivates the spirit of hard work, devotion, and dedication of personnels in realizing the goals of the National Cyber and Crypto Agency;
 - b. that based on the organizational transformation of the National Crypto Agency that to be the National Cyber and Crypto Agency, it is necessary to regulate the logo and flag of National Cyber and Crypto Agency;
 - c. that based on the considerations as referred to in point a and point b, it is necessary to issue a Regulation of National Cyber and Crypto Agency on the Logo and Flag of the National Cyber and Crypto Agency;

- Observing :
- Presidential Regulation Number 53 of 2017 on National Cyber And Crypto Agency (State Gazette of Republic of Indonesia of 2017 Number 100) as amended by Presidential Regulation Number 133 of 2017 on the Amendment to Presidential Regulation of the Republic of Indonesia Number 53 of 2017 on National Cyber and Crypto Agency (State Gazette of the Republic of Indonesia of 2017 Number 277);

HAS DECIDED:

To issue : REGULATION OF NATIONAL CYBER AND CRYPTO AGENCY ON LOGO AND FLAG OF NATIONAL CYBER AND CRYPTO AGENCY.

Article 1

Logo of the National Cyber and Crypto Agency consists of:

- a. the world globe that symbolizes the immensity of space in which the National Cyber And Crypto Agency takes on a global role in dealing with cybersecurity and cryptography challenges;
- b. Garuda Pancasila as the national emblem of the Republic of Indonesia represents the embodiment of the sovereignty of Unitary Republic of Indonesia in cyberspace and cryptography;
- c. red cayenne with 4 (four) grooves on the right side and with 4 (four) strands of green petals and white quill pen with 4 (four) indentations on the left side and 6 (six) indentations on the right side symbolizes the date of 4 (four) of April and year 1946 (one thousand nine hundred forty six) that is indicating as milestone of Cryptography of the Republic of Indonesia;
- d. cayenne and quill pen symbolizes the capacity of National Cyber and Crypto Agency in consolidating all cyber and cryptography resources to protect cyber diplomacy, cyber defense, digital economy, and national critical information infrastructure to attain economic growth and national security.
- e. the inscription of *Badan Siber dan Sandi Negara* along with its abbreviation BSSN as an affirmation of the organizational identity of the National Cyber and Crypto Agency;
- f. binary numbers on the world globe, the cayyene, and quill pen in digital connotation symbolizes that the National Cyber and Crypto Agency serves as the front line in building an information security values in the cyber era in order to realize a safe, friendly, and ethical cyber ecosystem;

- g. the blue color that symbolizes the calmness, loyalty, and guardianship symbolizes the National Cyber and Crypto Agency works professionally, integrity, adaptive to technology, and trustworthy to realize a secure atmosphere for public, nation, and state; and
- h. golden yellow color symbolizes optimism, independence, and greatness that the National Cyber and Crypto Agency is having self-conviction in utilizing national capabilities and strengths to counter cyber threats and attacks.

Article 2

The logo of the National Cyber and Crypto Agency is used for the purpose of position emblems, badges, flag, attributes, vandels, souvenirs, official stamps, and official manuscripts of the National Cyber and Crypto Agency.

Article 3

The shape and color of the National Cyber and Crypto Agency's logo as listed in Annex I which is an integral part of this Agency Regulation.

Article 4

The flag of the National Cyber and Crypto Agency consists of a yellow-based color with golden yellow tassel, and the logo of National Cyber and Crypto Agency in the center.

Article 5

The flag of the National Cyber and Crypto Agency is used as an attribute in the workroom of the head of National Cyber and Crypto Agency, meeting rooms, auditorium, and any place where official activities are held.

Article 6

The shape, color, and size of the National Cyber and Crypto Agency's flag are as listed in Annex II which is an integral part of this Agency Regulation.

Article 7

The logo and flag of the National Crypto Agency may be used until the organizational re-arrangement of the National Cyber and Crypto Agency is accomplished.

Article 8

At the time this Agency Regulation comes into force, the provisions regarding the logo and flag of the National Crypto Agency as regulated in the Regulation of the Head of National Crypto Agency Number 1 of 2010 on Logo and Flag of the National Crypto Agency Environment and Bumi Sanapati Education and Training Center is repealed and declared ineffective.

Article 9

This agency regulation comes into force on the date of its promulgation.

In order that every person may know hereof, it is ordered to promulgate this Agency Regulation by its placement in State Bulletin of the Republic of Indonesia.

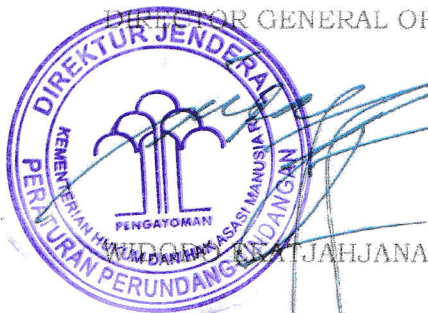

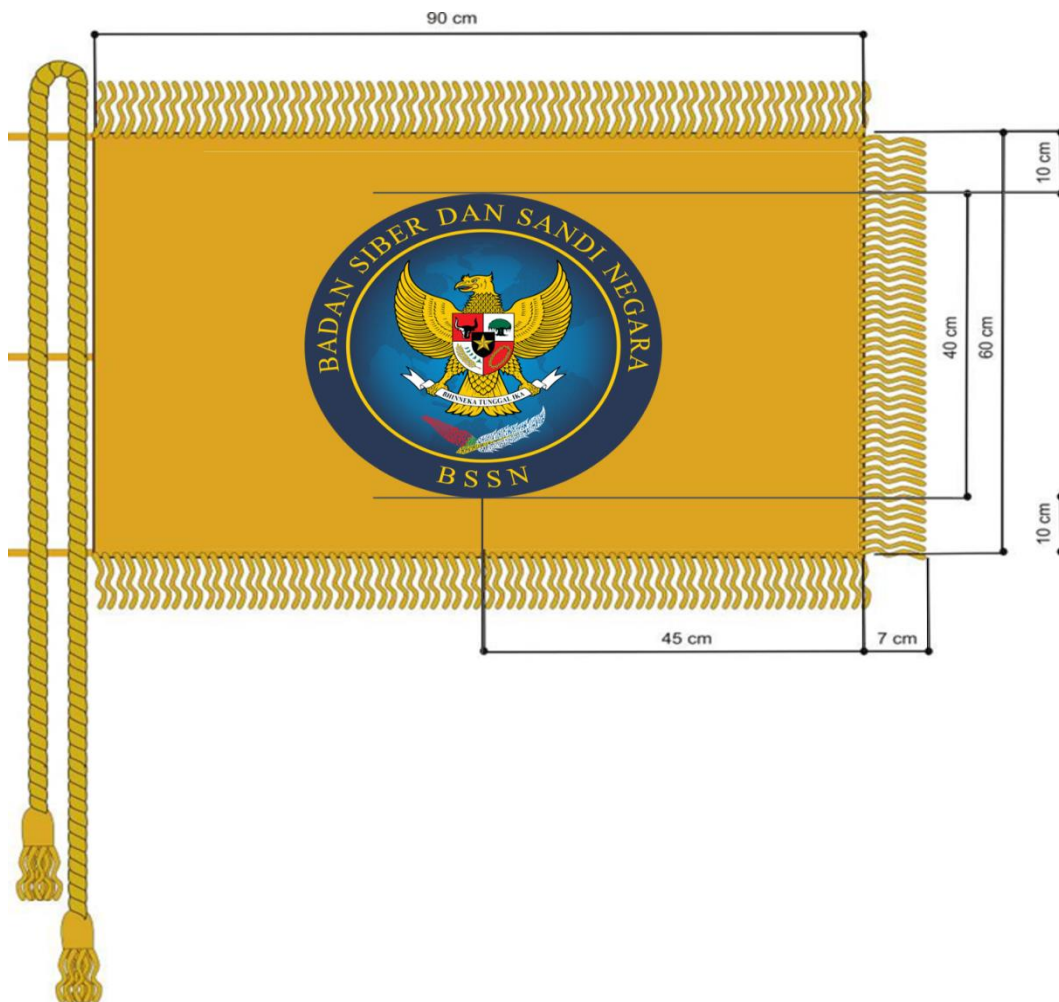
