BY THE BLESSINGS OF ALMIGHTY GOD

GOVERNOR OF LAMPUNG,

Considering:

- a. that Pancasila as the basis of the state, the ideology of the nation and the philosophy of life of the nation and the state is the responsibility of the state to be preserved in the life of the nation and state;
- b. that the fostering of Pancasila ideology and national insight is implemented to increase the understanding and practice of Pancasila, foster harmony and tolerance of a pluralistic society consisting of various religions, races, tribes, groups, social, economic and local cultures so that Lampung society with character and soul of Pancasila is realized;
- c. that the Lampung society consists of various tribes, religions, and cultures that grow and develop dynamically;
- d. that based on Article 25 section (1) and section (2) of Law Number 23 of 2014 on Local Governments, it is stated that the Governor fosters national insight and national resilience in order to strengthen the practice of Pancasila, the implementation of the 1945 Constitution of the Republic of Indonesia, the preservation of Bhinneka Tunggal Ika and the defense and maintenance of the integrity of the Unitary State of the Republic of Indonesia;
- e. that based on the considerations as referred to in point a, point b and point c and point d, it is necessary to establish a Regional Regulation on the Implementation of the Fostering of Pancasila Ideology and National Insight;

Observing :

- 1. Article 18 section (6) of the 1945 Constitution of the Republic of Indonesia;
- 2. Law Number 14 of 1964 on Enactment of Government Regulation in Lieu of Law Number 3 of 1964 on the Establishment of Level I Regions of Lampung by Amending Law Number 25 of 1959 on the Establishment of Level I Regions of South Sumatra, (State Gazette of 1964 Number 95) Supplement to the State Gazette Number 2688);
- 3. Law Number 12 of 2011 on Legislation Making as amended several times last by making a second amendment to Law Number 13 of 2022 on Second Amendment to Law Number 12 of 2011 on Legislation Making (State Gazette of the Republic of Indonesia Number 143 of 2022, Supplement to

the State Gazette of the Republic of Indonesia Number 6801);

4. Law Number 23 of 2014 on Local Governments (State Gazette of the Republic of Indonesia Number 244 of 2014, Supplement to the State Gazette of the Republic of Indonesia Number 5587) as amended several times, last by Law Number 6 of 2023 on the Enactment of Government Regulations in Lieu of Law Number 2 of 2022 on Job Creation to Become Law (State Gazette of the Republic of Indonesia of 2023 Number 41, Supplement to the State Gazette of the Republic of Indonesia Number 6856);
5. Government Regulation Number 18 of 2016 on Regional Apparatus (State Gazette of the Republic of Indonesia of 2016 Number 114, Supplement to the State Gazette of the Republic of Indonesia Number 5888) as amended by Government Regulation Number 72 of 2019 on Regional Apparatus (State Gazette of the Republic of Indonesia Number 187 of 2019, Supplement to the State Gazette of the Republic of Indonesia Number 6402);
6. Regulation of the Minister of Home Affairs Number 80 of 2015 on Establishment of Regional Legal Products (State Bulletin of the Republic of Indonesia Number 2015 Number 2036) as amended by Regulation of the Minister of Home Affairs Number 120 of 2018 on Amendment to the Regulation of the Minister of Home Affairs of the Republic of Indonesia Number 80 of 2015 on Establishment of Regional Legal Products (State Bulletin of the Republic of Indonesia of 2018 Number 157);

To Issue : REGIONAL REGULATION ON IMPLEMENTATION OF FOSTERING PANCASILA IDEOLOGY AND NATIONAL INSIGHT.

## CHAPTER I GENERAL PROVISIONS

### Article 1

In this Regional Regulation:

1. Region means the Province of Lampung.
2. Governor means the Governor of Lampung.
3. Local Government means the administration of government affairs by the Local Government and the

Regional House of Representatives according to the principle of autonomy and the duty of assistance with the principle of autonomy as widely as possible in the system and principles of the Unitary State of the Republic of Indonesia as referred to in the 1945 Constitution of the Republic of Indonesia.

4. Local Government means the Regional Head as an element of the Local Government administrator who leads the implementation of government affairs under the authority of the autonomous regions.
5. Regional Apparatus means an element of assistance to the Governor and the Regional House of Representatives in the administration of government affairs under the authority of the Region.
6. Regent/Mayor means the Regent/Mayor of the entire of Lampung.
7. Regency/Municipality means a Regency/Municipality in the Province of Lampung.
8. Fostering Pancasila Ideology (*Pembinaan Ideologi Pancasila*), hereinafter abbreviated to PIP, means an activity that is carried out effectively in terms of maintaining and perfecting the application and dissemination of the Pancasila ideology to all Indonesian citizens.
9. National Insight means the view held by the Indonesian people regarding their identity and homeland, with the main principles of unity and integrity in the life of the nation, state and society.

## Article 2

The implementation of Fostering Pancasila Ideology and national insight is carried out based on the following principles of:

- a. participation;
- b. equality;
- c. truth;
- d. openness;
- e. conformity;
- f. cooperation between parties;
- g. *gotong royong* (solidarity);
- h. creativity;
- i. academic; and
- j. local wisdom.

## Article 3

This Regional Regulation is intended to provide guidelines for policy makers in carrying out the implementation of fostering Pancasila ideology and National Insight.

## Article 4

This Regional Regulation aims to:

- a. inculcate Pancasila values and national insights;
- b. increase the appreciation and practice of Pancasila values in shaping the national character which is the basis for the actualization of Pancasila in the life of society and the state;

- c. embody the spirit of nationalism and love for the homeland;
- d. create unity and integrity of the Indonesian nation;
- e. realize harmony and peace in the community; and
- f. strengthen coordination of fostering Pancasila Ideology and national insight between the provincial government and the regency/municipal governments and other related institutions.

## CHAPTER II SCOPE

### Article 5

The scope of the Implementation of Fostering Pancasila Ideology and National Insight includes:

- a. implementation of fostering Pancasila Ideology and national insight;
- b. fostering of the ideology of Pancasila;
- c. national insight;
- d. public participation;
- e. cooperation;
- f. supervision, monitoring, evaluation; and
- g. funding.

## CHAPTER III IMPLEMENTATION OF FOSTERING PANCASILA IDEOLOGY AND NATIONAL INSIGHT

### Part One Implementation of Fostering Pancasila Ideology

#### Paragraph 1 General

### Article 6

The local government is obligated to implement the fostering Pancasila ideology.

### Article 7

- (1) The implementation of the fostering Pancasila ideology as referred to in Article 6 is carried out by the regional apparatus that administers government affairs in the field of:
  - a. National and Political Unity;
  - b. Education and Culture;
  - c. Youth and Sports; and
  - d. Other regional apparatus organizations.
- (2) The local government as referred to in section (1) in implementing the fostering Pancasila ideology can coordinate with:
  - a. regency/municipal governments;
  - b. vertical agencies/institutions; and
  - c. the public.
- (3) In addition to the regional apparatus as to referred in section (1), other regional apparatus may carry out the fostering Pancasila ideology in accordance with its duties

and functions by being guided by the provisions of legislation.

Paragraph 2  
Targets

Article 8

The implementation of fostering Pancasila ideology as referred to in Article 6 is aimed at:

- a. learners;
- b. political organizations;
- c. community organizations/other non-profit organizations;
- d. Civil Service;
- e. religious figures, indigenous peoples; and
- f. other groups.

Paragraph 3  
Execution

Article 9

The implementation of fostering Pancasila ideology is carried out through:

- a. dissemination;
- b. training education; and
- c. advocacy.

Article 10

The implementation of fostering Pancasila ideology through dissemination as referred to in Article 9 point a is carried out, among others, through:

- a. cultural activities;
- b. dissemination /seminars/workshops/technical guidance;
- c. commemoration of Pancasila's birthday; and/or
- d. other activities that support the fostering pancasila ideology.

Article 11

Training education as referred to in Article 9 point b is carried out through:

- a. intra-curricular activities;
- b. co-curricular activities;
- c. extracurricular activities; and/or
- d. non-curricular activities.

Article 12

- (1) The commemoration of the birthday of Pancasila as referred to in Article 11 point c is held on 1 June.
- (2) The form of commemoration of the birthday of Pancasila as referred to in section (1) is carried out with a ceremony.
- (3) In addition to the form as referred to in section (2), the commemoration of the birthday of Pancasila can be carried out by:
  - a. sports activities;
  - b. scientific activities;
  - c. social activities;
  - d. cultural activities; and/or

e. other activities.

(4) The implementation of the commemoration of the birthday of Pancasila as referred to in section (2) and section (3) is carried out in accordance with local wisdom.

#### Article 13

Advocacy as referred to in Article 9 point c, is carried out through non-litigation in accordance with the provisions of legislation.

#### Article 14

(1) The implementation of fostering Pancasila ideology can utilize information and communication technology.

(2) The utilization of information and communication technology as referred to in section (1) includes, among others, through:

- a. social media;
- b. broadcast media; and/or
- c. digital and non-digital formats.

(3) The local government provides support for information communication technology infrastructure as referred to in section (2).

(4) The implementation guidelines as referred to in section (1) are further regulated in a regulation of the regional head.

(5) The implementation guidelines as referred to in section (1) are further regulated in a Governor Regulation.

#### Article 15

(1) The local government prepares guidelines for the implementation of fostering Pancasila ideology.

(2) The implementation guidelines as referred to in section (1) contain at least:

- a. curriculum;
- b. module;
- c. study;
- d. research;
- e. material;
- f. discipline; and
- g. monitoring evaluation.

(3) Implementation guidelines are prepared by a drafting team formed by the local government.

(4) The drafting team as referred to in section (3) consists of the following elements:

- a. Local Government
- b. the Regional House of Representatives
- c. Academics

(5) The implementation guidelines as referred to in section (1) are further regulated in the regulation of the regional head.

#### Part Two Implementation of National Insight

##### Paragraph 1 General

### Article 16

The local government is obligated to organize the National Insight.

### Article 17

- (1) The implementation of national insight as referred to in Article 16 is carried out by the regional apparatus that administer government affairs in the field of:
  - a. National and Political Unity;
  - b. Education and Culture;
  - c. Youth and Sports; and
  - d. Other regional apparatus organizations.
- (2) The local government as referred to in section (1) in organizing the national insight may involve:
  - a. Regency/municipal governments;
  - b. Vertical agencies/institutions; and
  - c. the Public.
- (3) In addition to the regional apparatus as referred to in section (1), other regional apparatus may organize national insight in accordance with its duties and functions guided by the provisions of legislation.

### Paragraph 2 Targets

### Article 18

The implementation of national insight as referred to in Article 16 is aimed at:

- a. learners;
- b. political organizations;
- c. community organizations/other non-profit organizations;
- d. Civil Service;
- e. religious, community, and customary leaders; and
- f. other groups.

### Paragraph 3 Execution

### Article 19

The implementation of the national insight is carried out through:

- a. dissemination;
- b. Education and training; and
- c. Advocacy.

### Article 20

The implementation of national insight through dissemination as referred to in Article 19 point a is carried out, among others, through:

- a. cultural activities;
- b. dissemination /seminar;
- c. workshops/technical guidance;
- d. other activities that support national insights.

#### Article 21

Training education as referred to in Article 19 point b is carried out through:

- a. Intra-curricular activities;
- b. Co-curricular activities;
- c. Extracurricular activities; and/or
- d. Non-curricular activities

#### Article 22

Advocacy as referred to in Article 19 point c, is carried out through non-litigation in accordance with the provisions of legislation.

#### Article 23

- (1) The implementation of national insight can utilize information and communication technology.
- (2) The use of information and communication technology as referred to in section (1) includes, among others, through:
  - a. social media;
  - b. broadcast media; and/or
  - c. digital and non-digital formats.
- (3) The local government provides support for information communication technology infrastructure as referred to in section (2).

#### Article 24

- (1) The local government develops guidelines for the implementation of national insights.
- (2) The implementation guidelines as referred to in section (1) contain at least:
  - a. curriculum;
  - b. module;
  - c. study;
  - d. research;
  - e. material;
  - f. discipline; and
  - g. monitoring evaluation.
- (3) Implementation guidelines are prepared by a drafting team formed by the local government.
- (4) The drafting team as referred to in section (3) consists of the following elements:
  - a. Local Government
  - b. Regional House of Representatives
  - c. Academician
- (5) The implementation guidelines as referred to in section (1) are regulated in further provisions in the Governor's Regulation.

### CHAPTER IV

#### BASIC SUBSTANCES ON IMPLEMENTATION OF FOSTERING PANCASILA IDEOLOGY

#### Article 25

The basic substances on implementation of fostering Pancasila ideology include:

- a. Indonesian history;

- b. the history of the birth of Pancasila;
- c. the position of Pancasila in the life of the nation and state;
- d. the values of Pancasila; and
- e. actualization of Pancasila values.

## CHAPTER V BASIC SUBSTANCES ON IMPLEMENTATION OF NATIONAL INSIGHT

### Article 26

The basic substances on the implementation of national insight includes:

- a. the 1945 Constitution of the Republic of Indonesia
- b. Bhineka Tunggal Ika
- c. The Unitary State of the Republic of Indonesia,
- d. Actualization of national values; and
- e. local load.

## CHAPTER VI PUBLIC PARTICIPATION

### Article 27

- (1) Public participation in the implementation of fostering Pancasila Ideology and national insight includes:
  - a. actively participating as an agent of change and a driving force in implementing fostering Pancasila Ideology and national insight;
  - b. encouraging and supporting the implementation of fostering Pancasila Ideology and national insight;
  - c. helping succeed in the implementation of the fostering Pancasila ideology and national insight;
  - d. improving the capabilities and facilities they have to succeed in the implementation of fostering Pancasila ideology and national insights.
- (2) Public participation can be carried out through the forum for fostering Pancasila Ideology and national insight in the family.

### Article 28

- (1) The local government conducts an assessment of the implementation of public participation in the implementation of fostering Pancasila Ideology and national insight.
- (2) The assessment as referred to in section (1) is the basis for giving awards and/or appreciation to the public.
- (3) Assessment of the implementation of fostering Pancasila Ideology and national insight based on the following criteria of:
  - a. improvement of public services;
  - b. providing changes to the environmental conditions of the public; and
  - a. providing direct benefits to the public both functionally and economically.
- (4) The award as referred to in section (1) may be in the form of a certificate of award and/or publication.

(5) Assessment and award by the local government as referred to in section (1) and section (4) are carried out by the regional apparatus that administers government affairs in the field of national unity and politics.

## CHAPTER VII COOPERATION

### Article 29

(1) Provincial local governments can carry out cooperation in fostering Pancasila Ideology and national insight with regency/municipal governments.

(2) The cooperation as referred to in section (1) includes:

- a. institutions that organize government affairs in the field of fostering Pancasila and national insight;
- b. vertical agencies/institutions;
- c. other local governments;
- d. higher education institutions;
- e. community organizations;
- f. youth organizations;
- g. political party; and/or
- h. the public.

(3) The cooperation as referred to in section (1) is carried out in accordance with the provisions of legislation.

## CHAPTER VIII SUPERVISION, MONITORING AND EVALUATION

### Article 30

(1) The Governor conducts guidance, supervision, monitoring and evaluation of the implementation of Pancasila fostering and national insights.

(2) The supervision, monitoring and evaluation as referred to in section (1) are technically carried out by regional apparatus organizations in charge of government affairs in the field of National Unity and Politics.

(3) The Regional Apparatus Organization as referred to in section (2) in carrying out supervision, monitoring and evaluation coordinates with the relevant regional apparatus.

## CHAPTER IX FUNDING

### Article 31

Funding for the implementation of fostering Pancasila ideology and national insight can be sourced from:

- a. Local Budget; and/or
- b. other sources of income that are legitimate and non-binding.

CHAPTER X  
CLOSING PROVISION

Article 32

The Governor's Regulation as the implementing regulation of this Regional Regulation must be issued not later than 3 (three) months after this Regional Regulation is promulgated.

Article 33

This Regional Regulation comes into force on the date of its promulgation.

In order that every person may know hereof, it is ordered to promulgate this Regional Regulation by its placement in the Regional Gazette of the Province of Lampung.

## 1. GENERAL

The basic foundation of the state that has become the great work of the nation's founder, namely Pancasila, must be interpreted as a guide in the life of the state on all fronts. Through Presidential Decree Number 24 of 2016 on the Birthday of Pancasila (Presidential Decree on the Birthday of Pancasila), as a form of state recognition that Pancasila originated from Soekarno's Speech on 1 June 1945 in the first Session of BPUPKI led by dr. KRT Radjiman Wedyodiningrat has held an agenda to discuss the basis of the independent Indonesian state.

Through the Presidential Decree on the Birthday of Pancasila, the state also recognized the point of reaching a mutual agreement on the formulation of Pancasila based on the development of Soekarno's Speech on 1 June 1945 until the production of the Jakarta Charter on 22 June 1945 by the Committee of Nine and agreed to become the final formulation on 18 August 1945 by the Preparatory Committee for Indonesian Independence. In this sense, the understanding that the formulation of Pancasila from 1 June 1945 which was addressed by Ir. Soekarno, the formulation of the Jakarta Charter on 22 June 1945 to the final formulation on 18 August 1945 as a unit of the process of the birth of Pancasila as the Basis of the State.

The meaning of the unity of the process of the birth of Pancasila can also be understood that the final formulation of 18 August 1945 was imbued with Soekarno's Speech on June 1, 1945 and the Jakarta Charter of 22 June 1945. In other words, it is not possible to separate the formulation of Pancasila from the perspective of the 3 events respectively. Historically, the formulation of Pancasila on June 1, 1945 in Soekarno's speech, began with Soekarno giving his opinion on the purpose of the question of the Chairman of BPUPK Radjiman Wedyodiningrat, by explaining the concepts of *Philosophische grondslag* and *Weltanschaung*.

The application of fostering Pancasila Ideology itself cannot be separated from national insight as a coaching package for Indonesian citizens. Because national insight is a view owned by the Indonesian nation regarding its identity and homeland, with the main principle of unity and integrity in the life of the nation, state and society.
