MINISTER OF AGRICULTURE OF THE REPUBLIC OF INDONESIA,

- Considering :
- a. that the Regulation of the Minister of Agriculture Number 39 of 2019 on Import Recommendation of Horticulture Product, Horticulture Product Import Recommendation has been regulated;
 - b. that for the smooth implementation of the issuance of Import Recommendation of Horticulture Product, it is necessary to issue a Regulation of the Minister of Agriculture on Amendment to the Regulation of the Minister of Agriculture Number 39 of 2019 on Import Recommendation of Horticulture Product;
- Observing :

HAS DECIDED:

To issue: REGULATION OF THE MINISTER OF AGRICULTURE ON AMENDMENT TO THE REGULATION OF THE MINISTER OF AGRICULTURE NUMBER 39 OF 2019 ON IMPORT RECOMMENDATION OF HOLTICULTURE PRODUCTS.

Article I

Several provisions in the Regulation of the Minister of Agriculture Number 39 of 2019 on Import Recommendation of Horticulture Products (State Bulletin of the Republic of Indonesia of 2019 Number 845), amended as follows:

1. The provision of Article 15 is amended so that it reads as follows:

Article 15

- (1) The technical requirements as referred to in Article 10, include:

- a. Fresh Horticulture Products must comply with the provisions of the food safety for Fresh Food of Plant Origin (*Pangan Segar Asal Tumbuhan*, PSAT) in accordance with the provisions of legislation;
 - b. fresh Horticulture Products which its first time are exported from country of country of origin must be accompanied by risk analysis results of plant quarantine pest from the Indonesia Agriculture Quarantine Agency;
 - c. Certificate of Good Agriculture Practices/GAP or any equivalent certificate internationally recognized from the country of origin which is valid until the expiration date of its importation;
 - d. Certificate of Good Agriculture Practices/GAP or any equivalent certificate internationally recognized from the country of origin which is valid until expiration date of its importation;
 - e. statement letter from exporting country which declares production capacity of their farmland registered or certified Good Agriculture Practices/GAP; and
 - f. Imported Horticulture Products meet specified characteristics.
- (2) The technical requirements, as referred to in section (1) point c, point d, and point e, is translated into Bahasa Indonesia.
 - (3) In the even that a country has obtained the recognition of Food safety control system for Fresh Food of Plant Origin (PSAT) and still valid, then GAP, GHP, and statement letter from exporter of the country of origin regarding production capacity of the garden/farm land, as referred to in section (1) point c, point d, and point e.
 - (4) The provision as referred to in section (3) is valid for Horticulture Products that are listed in the annex of a Ministerial Decision on Recognition of Food Safety Control system for Fresh Food of Plant Origin (PSAT).
 - (5) Further provision regarding characteristic as referred to in section (1) point f is stipulated by the Director General on behalf of the Minister.

2. Provision of section (2) of Article 21 is deleted, so that Article 21 reads as follows:

Article 21

- (1) RIPH as referred to in Article 19 section 5 is valid if horticulture products have been loaded from country of origin not later than 31 December of current year.
- (2) Deleted.
- (3) Horticulture products as referred to in section 1 arrive in Indonesia not later than 60 (sixty) calendar days since they are loaded from country of origin and proven with all Import Declaration , *Pemberitahuan Impor Barang* (PIB).

3. Provision of section (3) of Article 22 is amended so that so that Article 22 reads as follows:

Article 22

- (1) Business Actors who have obtained RIPH, as referred to in Article 19 section (3), can apply for RIPH amendment.
- (2) RPIH amendment as referred to in section (1) will be in force mutatis mutandis in accordance with provision in Article 16 to Article 20.
- (3) Amended RIPH as referred to in section (1) will be valid if horticulture products are loaded by any transport from country of origin at least on the date of new RIPH issuance.
- (4) Horticulture Product as referred to in section (3) arrive in Indonesia not later than 60 (sixty) calendar days since being loaded into the transport mode from the country of origin and proven by Import Declaration , *Pemberitahuan Impor Barang* (PIB).

Article II

This Ministerial Regulation comes into force on the date of its promulgation.

In order that every person may know hereof, it is ordered to promulgate this Ministerial Regulation by its placement in the State Bulletin of the Republic of Indonesia.
