REGULATION OF THE MINISTER OF AGRICULTURE OF THE REPUBLIC OF INDONESIA NUMBER 39 OF 2019 ON IMPORT RECOMMENDATION OF HORTICULTURE PRODUCTS

BY THE BLESSINGS OF ALMIGHTY GOD

MINISTER OF AGRICULTURE OF THE REPUBLIC OF INDONESIA,

- that regulation of the Minister of Agriculture Number Considering : a. 38/PERMENTAN/HR.060/11/2017 on Import Recommendation of Horticulture Products as amended by Agriculture Regulation of the Minister of 24/PERMENTAN/HR.060/5/2018 on Amendment to Regulation of the Minister of Agriculture Number 38/PERMENTAN/HR.060/11/2017 Import on Recommendation of Horticulture Products;
 - b. that In order to enhance the efficiency and effectiveness of Horticulture Products import, it is necessary to amend Regulation of the Minister of Agriculture as referred to in point a;
 - c. that based on the considerations as referred to in point a and point b in order to implement Article 88 section (5) of Law Number 13 of 2010 on Horticulture, it is necessary to issue Regulation of the Minister of Agriculture on Import Recommendation of Horticulture Products;

HAS DECIDED:

To issue: REGULATION OF THE MINISTER OF AGRICULTURE ON IMPORT RECOMMENDATION OF HORTICULTURE PRODUCTS.

CHAPTER I

GENERAL PROVISIONS

Article 1

In this Ministerial Regulation:

- Horticulture means all matters related to fruit, vegetables, medicinal plants, and floriculture, including mushroom, moss, and water plants functioning as vegetables, medicinal plants and/or esthetics materials.
- 2. Horticulture Products mean all products originating from still fresh or already processed horticulture plants.
- Import of Horticulture Products means series of activity to take horticulture products into the territory of the Republic of Indonesia
- 4. Import Recommendation of Horticulture Products (*Rekomendasi Impor Produk Hortikultura*) hereinafter abbreviated as RIPH, means the written information which certifies that the Horticulture Product complies with the administrative and technical requirements.
- 5. Horticulture Importers hereinafter referred to as business actors mean business entities that operate their horticulture importation which are established and located in the jurisdiction of the Republic of Indonesia.
- 6. Business Identification Number (*Nomor Induk Berusaha*), hereinafter abbreviated as NIB, means the Identity of the Business Actor issued by the OSS Institution after the Business Actor has made the Registration.
- General Importer Identification Number (Angka Pengenal Importir Umum), hereinafter abbreviated as API-U, means the Identification as General Importer.
- 8. Producer Importer Identification Number (*Angka Pengenal Importir Produsen*) hereinafter abbreviated as API-P, means the Identification as Producer Importer.

- 9. Entry Points mean sea-ports, river-ports, crossing ports, air-ports, post offices, border posts and other places which are deemed necessarily appointed as entry points of Horticulture Product importation.
- 10. Minister means the minister who is in charge and responsible in the field of horticulture.
- 11. Director General of Horticulture hereinafter referred to as Director General means the high official in the Ministry of Agriculture who organizes his duty and function in the field of horticulture.
- 12. Head of Center for Plant Varieties Protection and Agricultural License (*Perlindungan Varietas Tanaman dan Perizinan Pertanian*) hereinafter referred to as Head of Center for PVTPP means the high official in the Ministry of Agriculture who organizes his duty and function in plant variety and agricultural license.

The scope of this Minister Regulation consists of:

- a. Requirement of the RIPH issuance;
- b. RIPH issuance procedure;
- c. obligation of Business Actors; and
- d. sanction provisions.

CHAPTER II

REQUIREMENT OF THE RIPH ISSUANCE

Part One General

- (1) RIPH is issued for the horticulture products:
 - a. fresh for consumption; and
 - b. fresh for industrial raw materials.
- (2) Horticulture products as referred to in section (1) are listed in the Annex I as an integral part of this Ministerial Regulation.

- (1) Import of Horticulture Products can be conducted by:
 - a. Business Actors;
 - b. social institutions; or
 - c. foreign country representatives/international organizations.
- (2) Business Actors, social institutions; or foreign country representatives/international organizations as referred to in the section (1) can conduct the Import of Horticulture Products after obtaining import license from the minister administering government affairs in the field of trade, after obtaining RIPH from the Director General on behalf of the Minister.
- (3) RIPH as referred to in the section (2) will be an annex as integral part of the import license.

Article 5

- Business Actors, social institutions; or foreign country representatives/international organizations can apply for RIPH in any time.
- (2) RIPH application as referred to in section (1) is processed in the work days.
- (3) RIPH application for next year can be submitted as of November in the current year.

- For the purpose of price and supply stability, Import of Horticulture Product may only be imported by State-Owned Enterprise
- (2) State-Owned Enterprise in Import of Horticulture Product as referred to in section (1), must be assigned by the Minister administering government affairs in the field of State Owned-Enterprise.
- (3) Minister administering government affairs in the field of State Owned-Enterprise in assigning as referred to in section (2), based on the result of the limited coordination meeting at the level of the minister for economy.

- Social Institution as referred to in Article 4 section (1) must be legal entity established by Indonesian Law and located in the Indonesia.
- (2) Foreign country representatives/international organizations as referred to in Article 4 section (1) are located in Indonesia.

Article 8

Import of Horticulture Products for:

- a. testing, research and science purposes;
- b. sample for not traded; and or
- c. personal passenger, crew of transport mode,

are excluded from this Ministerial Regulation.

Article 9

- Business Actors that conduct the Import of strategic Horticulture Products are obligated to develop strategic horticulture commodity domestically.
- (2) The obligation to develop strategic horticulture commodity as referred to in section (1) is based on type of strategic horticulture commodity as applied in the RIPH.
- (3) Development of strategic horticulture commodity as referred to in section (1) is regulated in Ministerial Regulation.

Part Two

Requirements

Article 10

To obtain RIPH, Business Actors, social institutions, and or foreign country representatives/international organizations as referred to in Article 4 must meet administrative and technical requirements.

Article 11

Administrative requirements as referred to in Article 10 for Business Actors include:

- a. Deed of establishment and its latest amendment;
- b. Resident Identification Card (*Kartu Tanda Penduduk*, KTP) of the head of company;
- c. business identification number applied for API-U for general importers;
- d. business identification number applied for API-P for industry;
- e. statement Letter which declares to use import of horticulture products in accordance with RIPH application for API-P holders, using Format-1;
- f. import realization of horticulture products from previous RIPH, whether it is realized or not, in accordance with RIPH, using Format-2; and
- g. stamped statement letter which declares all information is correct and valid, using Format-3.

Administrative requirements as referred to in Article 10 for State-Owned Enterprise which is assigned as referred to in Article 6 section (2) include:

- a. assignment letter from Minister administering government affairs in the field of State-Owned Enterprise; and
- b. business identification number applied for API-U.

Article 13

Administrative requirements as referred to in Article 10 for social institution include:

- a. KTP and/or Identity of the head of social institutions;
- b. deed of establishment of social institutions and its latest amendment;
- c. stipulation from the authorized Agency as social institutions;
- d. information from its country of origin of origin;
- e. beneficiary Information;
- f. statement letter which declares that horticulture products will not be for sale; and
- g. stamped statement letter which declares that all information is correct and valid using Format-3.

Administrative requirements as referred to in Article 10 for social institution for foreign country representatives/international organizations include:

- a. identity of head and/or representative assigned/represented;
- b. statement for internal purpose and not for sale; and
- c. stamped statement letter which declares that all information is correct and valid using Format-3.

- (1) Technical Requirements as referred to in Article 10 includes:
 - a. Fresh horticulture products must meet requirements for provisions of the food safety for Fresh Food of Plant Origin (*Pangan Segar Asal Tumbuhan*, PSAT) in accordance with the provisions of legislation;
 - b. fresh Horticulture Products which its first time are exported from country of country of origin must be accompanied by risk analysis results of plant quarantine pest from the Indonesia Agriculture Quarantine Agency.
 - c. Certificate of Good Agriculture Practices/GAP or any equivalent certificate internationally recognized from the country of origin which is valid until expiration date of its importation;
 - d. Certificate of Good Handling Practices/GHP issued by authorized agency from country of origin which is valid until expiration date of its importation;
 - e. statement letter from exporting country which declares production capacity of their farmland registered or certified Good Agriculture Practices/GAP; and
 - f. Horticulture Products meet requirements which have been stipulated.
- (2) Technical requirements as referred to in section (1) point c, point d and point e, are translated into Bahasa Indonesia by a sworn translator.

(3) Further provisions regarding characteristic as referred to in section 1 point f is stipulated by Director General on behalf of Minister of Agriculture in Ministerial Decision.

CHAPTER III RIPH ISSUANCE PROCEDURES

Article 16

- Business Actors, social institutions, and/or foreign country representatives/international organizations as referred to in Article 4 section (1) which will import horticulture products must apply RIPH to Director General via Head of Center for PVTPP by online;
- (2) Application as referred to in section (1) at least contains information of:
 - a. name and address of company;
 - b. name and address of head of company;
 - c. number and date of application;
 - d. name of horticulture products;
 - e. tariff line/HS Code;
 - f. country of origin;
 - g. plan of import volume;
 - h. plan of Entry Points; and
 - i. plan of import time.
- (3) Application as referred to in section (1) is accompanied by administrative and technical requirements as referred to in Article 11 to Article 15.

- (1) Application as referred to in Article 16 uses:
 - a. Format-4, fresh RPIH application for consumption;
 - b. Format-5, fresh RPIH application for industrial raw materials.
- (2) Head of Center for PVTPP after receiving application as referred to in Article 16 within a maximum for 3 work days will check all required administrative documents.

If result of checking required administrative documents as referred to in Article 17 section (2):

- a. complete, will be delivered to Director General using format-6; or
- b. incomplete, will be rejected,

by online.

Article 19

- Director General after receiving application as referred to in Article 18 point a will verify and validate all technical requirements within maximum 5 work days
- (2) If result of verification and validation as referred to in section (1):
 - a. complies with technical requirements, RIPH will be issued using Format-7; or
 - b. does not comply with technical requirements, RIPH will be rejected.
- (3) RIPH issued as referred to in section 2 point a will be delivered to Business Actors and Indonesia National Single Window (INSW) portal by Head of Center for PVTPP.
- (4) Rejection as referred to in section 2 point b will be delivered to Business Actors by Head of Center for PVTPP via online with reasons of rejection.
- (5) RIPH issued as referred to in section 3, will be valid for 1 (one) year, as long as complies with technical requirements as referred to in Article 15 section (1) point c and point d.

- (1) In the event of force majeure, Business Actors, Social Institutions, or foreign country representatives/international organizations as referred to in Article 4 section (1) can apply RIPH application by offline.
- (2) Force majeure as referred to in section (1) is event beyond human capacity and unavoidable which any activities cannot be held.
- (3) Force majeure as referred to in section (1) is stipulated by Director General Letter.

- RIPH as referred to in Article 19 section 5 is valid if horticulture products have been loaded from country of origin not later than 31 December of current year.
- (2) Loading process to transport mode as referred to in section1 is proven with:
- a. cargo manifest; and
- b. Bill of Lading (B/L) or Air Way Bill (AWB).
- (3) Horticulture products as referred to in section 1 arrive in Indonesia not later than 60 (sixty) calendar days since they are loaded from country of origin and proven with all Import Declaration, *Pemberitahuan Impor Barang* (PIB).

Article 22

- Business Actors that have been granted RIPH approval as referred to in Article 9 section (3), can apply for RIPH amendment.
- (2) RPIH amendment as referred to in section (1) will be in force mutatis mutandis in accordance with provision in Article 16 to Article 20.
- (3) Amended RIPH as referred to in section (1) will be valid if horticulture products are loaded by any transport from country of origin at least on the date of new RIPH issuance, proven with:
 - a. cargo manifest; and
 - b. Bill of Lading (B/L) or Air Way Bill (AWB).
- (4) Horticulture products as referred to in section (3) will arrive in Indonesia not later than 60 (sixty) calendar days since they are loaded by transport mode from country of origin and proven with Import Declaration (PIB)

Article 23

Format-1, Format-2 and Format-3 as referred to in Article 11; Format-4 and Format-5 as referred to in Article 17; Format-6 as referred to in Article 18 and Format-7 as referred to in Article 19 as listed in Annex II are an integral part of this Ministerial Regulation.

Further provisions regarding RIPH issuance procedures comply with legislation on Online Single Submission (OSS).

CHAPTER IV OBLIGATION OF BUSINESS ACTORS

Article 25

- (1) Business Actors that obtain RIPH approval are obligated to submit their RPIH to Minister administering government affairs in the field of trade for the issuance of Import License of Horticulture Products not later than 2 months as of RIPH issuance via online.
- (2) Business Actors that do not submit RIPH as referred to in section (1), their RIPH will be invalid.

Article 26

In the event of legal issues with regard to RIPH issuance, RIPH application will not be issued until final and binding court decision.

CHAPTER V

SANCTION PROVISIONS

- Business Actors that violate any provisions as referred to in Article 9 will be subject to sanction that their RIPH is not issued for 1 (one) year.
- (2) Business Actors that violate any provisions as referred to in Article 11 point e, will be subject to sanction that their RIPH is not issued for 1 (one) year and withdraw their horticulture products from distribution;
- (3) Business Actors that violate any provisions as referred to in Article 11 point g, will be subject to sanction that their RIPH is not issued for 3 (three) years.
- (4) Social Institutions that violate any provisions as referred to in Article 13 point f, will be subject to sanction that their

RIPH is not issued for 2 (two) years and withdraw their horticulture products from distribution;

- (5) Social Institutions that violate any provisions as referred to in Article 13 point g, will be subject to sanction that their RIPH is not issued for 3 (three) years.
- (6) Business Actors that violate any provisions as referred to in Article 15 section (1) point f, will be subject to sanction that their RIPH is not issued for 2 (two) years.
- (7) Business Actors that violate any provisions as referred to in Article 25 section 1, twice in a year, will be subject to sanction that their RIPH is not issued for 2 (two) years

CHAPTER VI

TRANSITIONAL PROVISIONS

- RIPH issued before this Minister Regulation come into force, will be declared valid until expiration of the RIPH.
- RIPH application submitted before this Minister Regulation (2)comes into force, will be processed in accordance with Regulation of Minister of Agriculture Number 38/PERMENTAN/ HR.060/11/2017 on Import Recommendation of Horticulture Products as amended by of the Minister of Agriculture Regulation Number 24/PERMENTAN/HR.060/5/2018 on Amendment to of the Minister of Regulation Agriculture Number 38/PERMENTAN/HR.060/11/2017 on Import Recommendation of Horticulture Products.
- (3) At the time this Minister Regulation comes into force, Horticulture Product of HS Code 0904.21.10 – Peppers (from Capsicum genus) is dried as listed in Annex I of this Minister Regulation taking into effect for 1 (one) month after the promulgation of this Ministerial Regulation.

CHAPTER VII CLOSING PROVISIONS

Article 29

At the time this Ministerial Regulation comes into force, Regulation of the Minister of Agriculture Number 38/PERMENTAN/HR.060/11/2017 on Import Recommendation of Horticulture Products (State Bulletin of the Republic of Indonesia of 2017 Number 1674) as amended by Regulation of the Minister of Agriculture Number 24/PERMENTAN/HR.060/5/2018 on amendment to Regulation of Minister of the Agriculture Number 38/PERMENTAN/HR.060/11/2017 on Import Recommendation of Horticulture Products (State Bulletin of the Republic of Indonesia of 2018 Number 743), are repealed declared ineffective.

Article 30

This Ministerial Regulation comes into force on the date of its promulgation.

In order that every person may know hereof, it is ordered to promulgate this Ministerial Regulation by its placement in the State Bulletin of the Republic of Indonesia.
