# REGULATION OF THE PRESIDENT OF THE REPUBLIC OF INDONESIA NUMBER 51 OF 2022

ON

# HEIRLOOM-FLAG HOISTING TROOP PROGRAM BY THE BLESSINGS OF ALMIGHTY GOD

### THE PRESIDENT OF THE REPUBLIC OF INDONESIA,

# Considering: a. that Pancasila as the basis and ideology of the state, and the way of life of the nation of Indonesia as well as the philosophy of the state as stated in the Preamble to the 1945 Constitution of the Republic of Indonesia, must be upheld and actualized in all aspects in the life of society, nation, and state;

- b. that in mainstreaming Pancasila within the framework of the Unitary State of the Republic of Indonesia with the value of Bhinneka Tunggal Ika (unity in diversity), it is necessary to foster Pancasila ideology in a planned, comprehensive, integrated and sustainable manner for the Heirloom-Flag Hoisting Troop that consists of the best youth of the nation and is established with the spirit of defending Pancasila which is symbolized in a belt that reads Pandu Ibu Indonesia Berpancasila (the Lighthouse of the Motherland of Indonesia with Pancasila);
- c. that the provisions regarding the Heirloom-Flag-Hoisting
  Troop in Presidential Regulation Number 13 of 2021 on
  Fostering Pancasila Ideology for Young Generation
  through the Heirloom-Flag Hoisting Troop Program needs
  to be in line with fostering Pancasila ideology;

d. that based on the considerations as referred to in point

 a, point b, and point c, it is necessary to issue a
 Presidential Regulation on the Heirloom Flag-Hoisting
 Troop Program;

#### Observing:

- 1. Article 4 section (1) of the 1945 Constitution of the Republic of Indonesia;
- Presidential Regulation Number 7 of 2018 on Agency for Fostering Pancasila Ideology (State Gazette of the Republic of Indonesia of 2018 Number 17);

#### HAS DECIDED:

To issue:

PRESIDENTIAL REGULATION ON HEIRLOOM-FLAG HOISTING TROOP PROGRAM.

## CHAPTER I GENERAL PROVISIONS

#### Article 1

In this Presidential Regulation:

- 1. Heirloom-Flag Hoisting Troop Program (*Program Pasukan Pengibar Bendera Pusaka*), hereinafter referred to as the Paskibraka Program, means a cadre program for prospective national leaders with Pancasila character.
- 2. Red and White Heirloom Flag (*Bendera Pusaka Sang Saka Merah Putih*), hereinafter referred to as the Heirloom Flag, means the state flag sewn by Madam Fatmawati and hoisted at the Proclamation of Independence of Indonesia on 17 August 1945 at Pegangsaan Timur Street Number 56 Jakarta which is stored and preserved at the Jakarta National Monument.
- 3. Agency means an agency administering the Government affairs in the field of fostering Pancasila ideology.
- 4. Heirloom-Flag Hoisting Troop hereinafter referred to as Paskibraka means the best students who are the nation's cadres assigned to hoist/lower duplicates of the Heirloom Flag at the commemoration ceremony of the Anniversary

- of the Proclamation of Independence of the Republic of Indonesia and the commemoration ceremony of the Birth of Pancasila at the national/central, provincial, and regency/municipal level.
- 5. Alumnus of Heirloom-Flag Hoisting Troop (*Purnapasukan Pengibar Bendera Pusaka*) hereinafter referred to as Purnapaskibraka means Paskibraka who has completed the assignment of hoisting/lowering a duplicate of the Heirloom Flag at the commemoration ceremony of the Anniversary of the Proclamation of Independence of the Republic of Indonesia and the commemoration ceremony of the Birth of Pancasila.

## CHAPTER II PASKIBRAKA PROGRAM

#### Article 2

The Paskibraka Program is based on Pancasila and the 1945 Constitution of the Republic of Indonesia.

#### Article 3

- (1) The national Paskibraka Program is under the coordination of the Agency.
- (2) The implementation of the Paskibraka Program at the central level is under the coordination of the Agency.
- (3) The implementation of the Paskibraka Program at the provincial and regency/municipal level is under the coordination of the Agency through the ministry administering domestic government affairs.

- (1) The Paskibraka Program is implemented for Paskibraka, Purnapaskibraka, and Purnapaskibraka of Pancasila Ambassadors, as well as for heirloom-flag hoisting troop activities.
- (2) Paskibraka Program includes:
  - a. formation of Paskibraka;

- b. the assignment of Paskibraka;
- c. appointment of Purnapaskibraka of Pancasila Ambassadors;
- d. implementation of the duties of Purnapaskibraka of Pancasila Ambassadors;
- e. advanced fostering for Purnapaskibraka of Pancasila Ambassadors; and
- f. fostering on heirloom-flag hoisting troop and Purnapaskibraka activities.
- (3) The Paskibraka Program as referred to in section (1) is implemented in a planned, integrated, comprehensive, and sustainable manner.

## CHAPTER III FORMATION OF PASKIBRAKA

#### Article 5

- (1) The formation of Paskibraka is carried out through the following stages:
  - a. recruitment and selection;
  - b. centralization of education and training; and
  - c. inauguration of Paskibraka.
- (2) Further provisions regarding the establishment of Paskibraka as referred to in section (1) are regulated in an Agency Regulation.

- (1) At the time of inauguration, Paskibraka candidates are obligated to declare Ikrar Putra Indonesia (Promise of Indonesian Youth), to be loyal to Pancasila, the 1945 Constitution of the Republic of Indonesia, the Unitary State of the Republic of Indonesia, and Bhinneka Tunggal Ika.
- (2) The Ikrar Putra Indonesia as referred to in section (1) reads as follows:
  - "I declare that I am Indonesian Youth and based on that declaration, I declare that I am a creature of God, the

almighty creator, and originate from Him.

I declare that I have one blood, the homeland of Indonesia. I declare that I have one nation, the nation of Indonesia.

I declare that I have one state, the Unitary State of the Republic of Indonesia, which is based on Pancasila and the 1945 Constitution of the Republic of Indonesia.

I declare that I have one spirit and ideology, the spirit and ideology of Pancasila, and the 1945 Constitution of the Republic of Indonesia.

I declare that I have one objective, a just and prosperous society based on Pancasila.

I declare that diversity is embedded in the cultural unity of the nation.

I declare that I am the next generation of the great struggle for independence with virtue and righteousness by the will of the Almighty God.

By virtue of these declarations and for the sake of my honor as a cadre of the nation, I promise that I will conscientiously fulfill my obligation to practice the declarations in the course of my daily life.

May the Almighty God bless my intention with His divine help and guidance as well as His protection."

## CHAPTER IV ASSIGNMENT OF PASKIBRAKA

- (1) The Paskibraka is assigned to the commemoration ceremony of the Anniversary of the Proclamation of Independence Day of the Republic of Indonesia and the commemoration ceremony of the Birth of Pancasila.
- (2) In addition to the assignment as referred to in section (1), the Paskibraka may be assigned to task for other official events.
- (3) Further provisions regarding the assignment of Paskibraka are regulated in an Agency Regulation.

#### Article 8

- (1) Duplicates of the Heirloom Flag are made in a size in accordance with the provisions of legislation.
- (2) The making of duplicates of the Heirloom Flag as referred to in section (1) is carried out by the Agency after obtaining approval from the ministry administering government affairs in the field of state secretariat.
- (3) The Agency distributes duplicates of the Heirloom Flag as referred to in section (2) to the Central Government, local governments, and Indonesian missions abroad and other institutions.

#### CHAPTER V

## APPOINTMENT OF PURNAPASKIBRAKA OF PANCASILA AMBASSADORS

#### Article 9

- (1) The Purnapaskibraka is appointed as Pancasila Ambassadors.
- (2) The appointment of the Purnapaskibraka of Pancasila Ambassadors as referred to in section (1) is determined by the Agency.
- (3) Further provisions regarding the appointment of the Purnapaskibraka of Pancasila Ambassadors are regulated in an Agency Regulation.

#### CHAPTER VI

# IMPLEMENTATION OF THE DUTIES OF PURNAPASKIBRAKA OF PANCASILA AMBASSADORS

- (1) The Purnapaskibraka of Pancasila Ambassadors are obligated to:
  - a. uphold the consensus of the nation and state, namely Pancasila, the 1945 Constitution of the Republic of Indonesia, the Unitary State of the

- Republic of Indonesia, and Bhinneka Tunggal Ika;
- set an example/be a role model in mainstreaming
   Pancasila in various aspects of life in society, nation,
   and state;
- c. instill the values of Pancasila, nationalism, unity, and integrity, patriotism, and willingness to sacrifice for the interests of the nation within the framework of the Unitary State of the Republic of Indonesia in organizations, communities, and society in various fields; and
- d. implement other duties assigned by the Head of the Agency.
- (2) Further provisions regarding the implementation of the duties of the Purnapaskibraka of Pancasila Ambassadors are regulated in an Agency Regulation.

#### CHAPTER VII

# ADVANCED FOSTERING FOR PURNAPASKIBRAKA OF PANCASILA AMBASSADORS

#### Article 11

- (1) The Agency conducts advanced fostering of the Purnapaskibraka of Pancasila Ambassadors.
- (2) The advanced fostering as referred to in section (1) consists of:
  - education and training for fostering the Pancasila ideology; and
  - b. mainstreaming of Pancasila.
- (3) Further provisions regarding the advanced fostering as referred to in section (2) are regulated in an Agency Regulation.

#### CHAPTER VIII

#### PASKIBRAKA PANCASILA AMBASSADOR OF INDONESIA

#### Article 12

(1) The Purnapaskibraka of Pancasila Ambassadors are

- accommodated in the organization of Paskibraka Pancasila Ambassador of Indonesia.
- (2) The Paskibraka Pancasila Ambassador of Indonesia as referred to in section (1) are under the authority of and are responsible to the Head of the Agency.

#### Article 13

- (1) The Paskibraka Pancasila Ambassador of Indonesia consists of the following levels:
  - a. center;
  - b. province; and
  - c. regency/municipality.
- (2) The management of the Paskibraka Pancasila Ambassador of Indonesia as referred to in section (1) consists of:
  - a. advisor;
  - b. executive; and
  - c. secretariat.

- (1) The advisor of Paskibraka Pancasila Ambassador of Indonesia at the central level consistS of:
  - a. advisory council; and
  - b. advisory members.
- (2) The advisory council as referred to in section (1) point a is held ex officio by:
  - a. Chairperson of the Steering Council of the Agency;
  - the minister administering the coordination, synchronization, and control of ministerial/institutional affairs in administering the government affairs in the field of politics, law, and security;
  - c. the minister administering the coordination, synchronization, and control ministerial/institutional affairs in administering the affairs in field government the of human development and culture;

- d. the minister administering domestic government affairs; and
- e. Head of the Agency.
- (3) The advisory members as referred to in section (1) point b are held ex officio by madya middle-level senior leadership officials in charge of:
  - a. coordination of the mental revolution in the ministry administering the coordination, synchronization, and control of ministerial/institutional affairs in administering the government affairs in the field of human development and culture;
  - b. general government in the ministry administering domestic government affairs;
  - c. regional finance in the ministry administering domestic government affairs;
  - d. religious education in the ministry administering government affairs in the field of religious affairs;
  - e. secondary education in the ministry administering government affairs in the field of education;
  - f. regulations in the ministry administeringgovernment affairs in the field of law and human rights;
  - g. human rights in the ministry administeringgovernment affairs in the field of law and human rights;
  - h. youth development in the ministry administeringgovernment affairs in the field of youth and sports;
  - i. education and training on fostering Pancasila ideology in the Agency; and
  - j. control and evaluation in the Agency.
- (4) The Advisory Council as referred to in section (2) is led by the Chairperson of the Steering Council of the Agency.
- (5) The Advisors as referred to in section (1) are appointed by the Head of the Agency with the approval of the Chairperson of the Steering Council of the Agency.

#### Article 15

- (1) The executive of the central level of Paskibraka Pancasila Ambassador of Indonesia consists of:
  - a. deliberative assembly;
  - b. general chairperson;
- (2) vice chairperson I;
  - c. vice chairperson II;
  - d. general secretary; and
  - e. heads of departments.
- (3) The Deliberative Assembly as referred to in section (1) point a comprises the elements of:
  - a. Purnapaskibraka; and
  - b. national figures.
- (4) General chairperson, vice chairperson I, vice chairperson II, general secretary, and heads of departments as referred to in section (1) point b to point f are Purnapaskibraka of Pancasila Ambassadors.
- (5) The executive as referred to in section (1) is appointed by the Head of the Agency.

#### Article 16

The central level secretariat of the Paskibraka Pancasila Ambassador of Indonesia is appointed by the Head of the Agency.

#### Article 17

- (1) The advisor of Paskibraka Pancasila Ambassador of Indonesia at the provincial level is held ex officio by the governor.
- (2) The executive and secretariat of Paskibraka Pancasila Ambassador of Indonesia at the provincial level are appointed by the governor with the approval of the Head of the Agency.

#### Article 18

(1) The advisor of Paskibraka Pancasila Ambassador of Indonesia at the regency/municipal level is held ex officio

by the regent/mayor.

(2) The executive and secretariat of Paskibraka Pancasila Ambassador of Indonesia at the regency/municipal level are appointed by the regent/mayor with the approval of the Head of the Agency.

#### Article 19

Further provisions regarding the organizational structure and work procedures of the Paskibraka Pancasila Ambassador of Indonesia are regulated in an Agency Regulation.

#### Article 20

- (1) The Agency provides fostering to the Paskibraka Pancasila Ambassador of Indonesia.
- (2) The fostering as referred to in section (1) consists of:
  - a. the formation of members;
  - b. the competency improvement of members;
  - c. the activities of heirloom-flag hoisting troop; and
  - d. the activities of the mainstreaming of Pancasila.
- (3) Further provisions regarding the fostering as referred to in section (2) are regulated in an Agency Regulation.

#### CHAPTER IX

# FOSTERING ON THE ACTIVITIES OF HEIRLOOM-FLAG HOISTING TROOP AND PURNAPASKIBRAKA

- (1) The Agency provides fostering:
  - a. on the activities of heirloom-flag hoisting troop; and
  - b. to Purnapaskibraka.
- (2) The fostering as referred to in section (1) is carried out in the context of the mainstreaming of Pancasila.
- (3) Further provisions regarding the fostering as referred to in section (1) are regulated in an Agency Regulation.

## CHAPTER X FUNDING

#### Article 22

- (1) The Central Government and local governments provide funding for the Paskibraka program.
- (2) The funding as referred to in section (1) is obtained from:
  - a. State Budget;
  - b. local budget; and/or
  - c. other legitimate and non-binding sources in accordance with the provisions of legislation.
- (3) The funding from the local budget as referred to in section (2) point b is used for the Paskibraka program in the provincial and regency/municipal levels which is general government affairs.

# CHAPTER XI TRANSITIONAL PROVISIONS

#### Article 23

The 2022 Paskibraka Program funding which is obtained from local budget or other sources as agreed by Local Governments or authorized officials is valid until the end of 2022 fiscal year or based on the determination/approval in accordance with the provisions of legislation.

#### Article 24

The organization of Paskibraka Pancasila Ambassador of Indonesia which is established in accordance with Presidential Regulation Number 13 of 2021 on Fostering Pancasila Ideology to Young Generation through Heirloom-FlagHoisting Troop Program remains to be recognized and obligated to adjust its organizational structure not later than 12 (twelve) months after this Presidential Regulation comes into force.

# CHAPTER XII CLOSING PROVISIONS

#### Article 25

At the time this Presidential Regulation comes into force, the implementing regulation of Presidential Regulation Number 13 of 2021 on Fostering Pancasila Ideology to Young Generation through Heirloom-FlagHoisting Troop Program (State Gazette of the Republic of Indonesia of 2021 Number 65), is declared to remain effective to the extent not contrary to the provisions of this Presidential Regulation.

#### Article 26

At the time this Presidential Regulation comes into force, Presidential Regulation Number 13 of 2021 on Fostering Pancasila Ideology to Young Generation through Heirloom-FlagHoisting Troop Program (State Gazette of the Republic of Indonesia of 2021 Number 65), is repealed and declared ineffective.

#### Article 27

This Presidential Regulation comes into force on the date of its promulgation.

In order that every person may know hereof, it is ordered to promulgate this Presidential Regulation by its placement in the State Gazette of the Republic of Indonesia.
